**** Please note that an annual commitment is required for all programs. You are responsible for payment for the entire duration of the program (a full academic year) even if you choose to withdraw your child from the program before its completion. ****

- **A late fee of \$1 dollar** (if applicable) will be applied for every minute a parent is late to pick up their child. This fee will be applied to the monthly tuition.
- **All payments are non-refundable** except in cases of program cancellation due to low enrollment.
- ChiCeLaCu! follows the FCPS calendar with respect to teacher workdays, holidays, and school cancellations. If schools are cancelled due to inclement weather, ChiCeLaCu! will schedule in-person makeup classes after May 18 or continue with classes online. **If FCPS closes due to Covid-19 or if there is an outbreak in class or school, ChiCeLaCu! will continue with classes online.** ChiCeLaCu! will continue to implement its Covid-19 Safety Guidelines. To participate in the program, children must be healthy and show no sign of illness as described in the guidelines.
